WATER MAINTAINANCE TALON COGHILL



Water | General Maintenance

Hello Yale First Nation members and staff. As you may know I've been working on the YFN maintenance team for 2 years now. I have lived on reserve for many years and seeing our nation grow and develop is great. Increases in accessibility, resources and opportunities.

Maintenance will now be led by Brandon. I have worked with Brandon for many months, and he has earned my trust as a coworker, member and individual. Seeing his effort and value to our elders and youth has already positively impacted our community and he is a great addition to our team and community. So, this means I will no longer be our main contact for maintenance.

I have recently as of March become our nation's main water operator, I will still be doing maintenance, but my priority will be water operations. What does this entail? It means that I will be working for our nation under contract to provide potable water to our community buildings, greenhouse and home connections.

Potable Water: What it Means

Potable Water is water that is safe for ingestion, also may be known as safe or clean drinking water. The term is simple but how we get there requires infrastructure, resources and training.

As the water operator I work with Mark Turner, Environmental Health Officer to ensure water samples are taken according to Canadian Drinking Water Guidelines standards. I also work with the Circuit Rider Bruce that is contracted by ISC to assist many nations with repairs, training and maintenance to our water system.

As water operator I work according to Yale, FNHA, provincial and local water guidelines. I will inform, listen and work accordingly. If you have water related questions you can send me an email.

I will also be present at our next band meeting, so members will be able to ask me questions in our Q&A period.

Soon I will connect with voluntary members to do water testing and samples at individual's homes. For daily water testing I use a colorimeter and a reagent that allows me to measure chlorine levels. For water sampling I fill a container that has a chlorine neutralizer. I send these samples to a lab to test for bacteria such as e-coli. These samples are sent off 4 times per month which comes out to once a week sampling.

Ideal Water

I have previously submitted a FNHA sponsored program called Flush Until Cold initiative. This initiative is to make sure the water for ingestion is fresh. The water in pipes can sometimes sit and warm up to ambient pipe temperatures. It's best to run water for 15 seconds or until water is cold for the cleanest water.

Pools

Let me know if you want any assistance this year with filling your pool or chlorinating your pool. Water is a precious resource, and I kindly ask that you request my assistance so we can conserve our precious water and reduce water loss due to leaks, multiple fillings or lack of cleaning/chlorinating.



I'd like to take a moment to share some updates on the ongoing work I've been involved in on behalf of Yale First Nation.

As part of our Community Comprehensive Planning (CCP) project, I continue to work closely with our mentor Shirley Patt. We are planning an Elders Meet & Greet with her at the end of May to ensure our elders' voices are heard in the planning process.

We're also preparing for our upcoming Band Meeting on Saturday, May 24th, where we will be reviewing the 2024/2025 audit. In addition, our departments will be introducing themselves and sharing more about the programs and services they offer to members. In the background, we continue to work diligently on submitting previously unreported reports, making steady progress toward full compliance.

I've also continued working alongside Michael from the First Nations Financial Management Board (FMB) to guide staff in developing their departmental budgets and work plans. We are also reviewing and refining our policies—including the Financial Administration Law, HR, Governance, Information Management, and Work Policy. Once we've finalized the drafts, we look forward to sharing them with you, our membership, for feedback before Chief and Council give the final approval.

We are currently facing vacancies in our health department, and I am actively working with FNHA to bring in a nurse to provide support and ensure continuity of care for our members.

And now for some exciting news—we are in the process of securing funding for two new community play parks and cemented sports areas in both of our main communities! Once funding is confirmed, we will begin the planning phase with our children and families, ensuring this space is created with their voices and needs at the forefront. As we grow in our culture and community, we are also looking ahead physically. We are actively seeking funding to expand our community centres, making them more accommodating for larger gatherings, ceremonies, and celebrations that bring us together as a people. These spaces hold our laughter, our teachings, and our healing—so it's important we nurture them just as we do our spirit and culture.

A Personal Reflection

On a personal note, I recently completed my first cohort of Halq'eméylem language learning, which began in September 2024 and wrapped up this past February. This journey has been nothing short of transformative. To speak the language of my ancestors, to hear the rhythm of our stories in our original tongue—it stirred something deep within me. It reminded me of who I am, where I come from, and the responsibility I carry as both a learner and a leader.

There was a profound sense of belonging that came with each word spoken, a spiritual connection to the land, to my family, and to all those who walked before us. I hold hope and excitement for the next cohort starting in the fall of 2025, and I look forward to continuing the path of revitalizing our language—so long as it aligns with my ongoing responsibilities to our Nation.

I am truly grateful to be part of the many beautiful moments of growth we've been experiencing within our Nation. Words can hardly express how proud I am of our people. Thank you for allowing me to witness your journey, your strength, and your unwavering spirit. No matter what challenges we face, we continue to rise—together. We hold each other up, we support one another, and through that unity, our strength only grows. It is an honor to walk this path with all of you.

FISHERIES DEPARTMENT DOMINIC HOPE

At this time of year, we would be expecting the migration of Eulachon to parts of the Lower Fraser. If high enough of an abundant return, the Lower Fraser First Nations have an understanding and arrangement in place to receive some Eulachon to share within respective communities from those that have immediate and ongoing access to these. To date, the returns and catches have been very low. However, the main Eulachon fishing communities ie: Katzie and Kwantlen are optimistic that the catches will pick up Mid April. If this unfolds as anticipated, then YFN may receive a portion of Katzie catch to share within our community. Elders will receive a feed or a meal worth if enough to go around. If a bit more than that will result in further distribution in the community. Please inform if you would like to receive Eulachon if available and even inform if you would like to pass on this opportunity. Keep in touch as catches come randomly and I will be called to pick some up on short notice.

Chinook

There continues to be conservation concerns with the Early migrating Chinook (referred to as Spring 4(2), Spring 5(2) and Summer 5(2). SFO has had management actions and license conditions in place to limit impacts on these stocks. Recent years has provided focussed efforts and harvest on the Summer 4 (1) stocks which typically has fishing opportunities 2nd week to mid August for our first Communal Fisheries. The delay in the initial fisheries is to protect the Sum 5 (2) and let more of them to migrate through the system beyond our fishing area. These protection efforts have shown positive results in that FN impacts on these earlier stocks has lessened. However it has been revealed that the Sports / Recreational sector has increased impacts on these stocks of concern. First Nations of various tables and organizations are trying to work with DFO to correct and improve upon DFOs management regime which clearly contravenes aboriginal priority rights. In particular the Fraser Salmon Management Council has a Collaborative Management Agreement with DFO to manage Fraser migrating Salmon. Within this agreement is a Fraser Salmon Management Board which consists of 4 DFO and 4 Member FNs Regionally based(Upper Fraser FN / Mid Fraser / Lower Fraser and Marine-Approach FN). This Board is tasked with increasing management and decision making. It is here that FNs have expectations of more meaningful involvement in decision making. More on this as developments progress.

Sockeye

It is forecasted that sockeye returns be low to moderate which is improved over recent years which had extremely low returns due to various factors. There's not an expectation to have large sockeye directed fisheries, but enough to have minimal sockeye directed fisheries or enough to support by-catch impacts of sockeye caught during chinook directed fisheries for example. The likelihood of a Dry Rack Fishery is low despite ongoing efforts to get the dry rackers out there fishing in traditional manners with some flexibility in DFOs policies to allow for this minimal impact culturally significant fishery.

In recent years there has been conservation window closures in place intended to protect certain species and stocks. It is yet to be decided on whether the Early Stuart closure will be a 3-4 or 5 week duration and the dates associated and similar with the Coho Closure and the Steelhead Closure. More on these as they are confirmed As the fishing season nears, please ensure that you provide updated contact information to Dominic and Connie so that you can receive any last minute fishing opportunities and information through out the season.

Good day, Yale First Nation Members,

Here is a quick update from our Housing Department: Several of our homes in the community have recently undergone energy efficiency upgrades to help keep them warmer during the winter months and cooler in the summer. Some homes have had heat pumps installed, which will make a big difference in maintaining comfortable temperatures year– round. With some of the roofs needing replacement, we have installed metal roofing as a part of our ongoing fire mitigation efforts. A number of homes have also been renovated to address mold issues and complete other necessary upgrades.

All of this work is being done to help extend the life of the homes on Yale First Nation, making sure they stay safe and livable for years to come. Starting this month- and likely continuing into next month- we will begin emptying the septic tanks for all homes. While doing this, we will also take the opportunity to check the condition of each system. This will help us identify any necessary repairs or maintenance that should be done now to prevent larger issues in the future.

Rental application forms are available on our website or can be picked up at the office. Please remember to renew your application each year to stay on the housing list. This helps us better plan for housing needs, including making sure the right size of home is assigned. And a friendly reminder: if your home needs any kind of repairs or maintenance, please fill out a maintenance request form. You can pick up the forms at any of our community buildings or at the office. Iven our maintenance team carries forms with them. Once filled our, you can drop it off at the office or hand it directly to a member of the maintenance team. This helps us track urgent needs and ensure nothing gets missed.





FireSmart Initiatives

We finalized the Community Wildfire Resiliency Plan, continued work on the Emergency Management Plan and Community Hazard Assessment, and supported the Maintenance Department on projects that help promote the well-being of YFN members and community infrastructure.

We have also been focused on securing additional funding to continue wildfire mitigation and FireSmart initiatives in the community. These efforts are vital in reducing the risk of wildfire and protecting our homes, lands, and infrastructure.

With warmer weather on the way, spring runoff is approaching quickly. We encourage all community members to stay alert and report any signs of flooding, drainage issues, or erosion concerns to Daryl - YFN Emergency Program Coordinator.

Hello YFN Members,

I hope this message finds you all well.

First, I would like to acknowledge our Elders for their continued strength, resilience, and for sharing the rich history of Yale First Nation's traditional lands and culture. Your guidance grounds us as we continue to move forward together.

Yale First Nation Council will be meeting with Enbridge later this month. Due to the upcoming Sunrise Expansion Project, meetings between YFN and Enbridge will become more frequent. This project proposes to increase the flow of natural gas through the existing Enbridge pipeline that runs through our territory. YFN Council is committed to using all available resources to ensure that negotiations are fair and that any decisions made are in the best interest of our Nation and completed in a timely manner.

YFN also holds a forestry tenure license, allowing us to harvest timber annually, as permitted by the BC Ministry of Forests. This license is a significant opportunity for our Nation. However, last year, Council made the decision to decline harvesting in the designated cut blocks due to concerns about the potential impacts—not only for our own lands, but for neighbouring communities as well. Council is now actively exploring other alternatives for timber harvesting in areas that better align with our values and environmental stewardship.

We are also mindful of the uncertain future of forestry exports, especially with the ongoing volatility in U.S. trade policies and tariffs, which could impact First Nations across Canada.

In addition, Yale First Nation has entered into a limited partnership with Vine Maple. The company has proposed an open-pit mining project near Nickel Mine Road. They are currently undergoing the regulatory permitting process through the BC Ministry of Mines, BC Ministry of Forests, and the Provincial Regulatory and Reclamation Office (PRRO). We are monitoring this closely and will ensure the interests of YFN and the community remain at the forefront.

Lastly, our upcoming Band Meeting is just around the corner. We encourage everyone to attend, participate, and share what matters most to you. Your voice is vital as we work together to shape the future of our Nation.

It continues to be an honor to serve Yale First Nation. Let's forge a path forward together, and ensure a strong, sustainable future for the next generations.

Railway Crossings on YFN Lands

Chief and Council would like to provide an important update regarding the railway crossings located within our traditional territory and reserve lands. These crossings are not only essential routes for our community to access their homes, but also connect us to our traditional fishing grounds, ceremonial teaching sites, and the final resting places of our loved ones.

We have formally written to Canadian Pacific Kansas City (CPKC), the company responsible for the railway, to address our concerns and remind them of their obligations. The key locations include:

- Yale Town (IR1)
- Stullawheets (IR8)
- Lukseetsissum (IR9)
- Albert Flat (IR5)

We are holding CPKC accountable for the ongoing maintenance, safety, and monitoring of all crossings that run through our lands. These crossings are deeply connected to our way of life, and we are committed to ensuring our members have safe and reliable access.

We have requested a formal meeting with CPKC to discuss their responsibilities and ensure they uphold their duty to Yale First Nation.

We will continue to update you as this discussion progresses.

Seeking Economic Opportunities with B.C. Parks

Chief and Council would like to share that we have reached out to B.C. Parks to express Yale First Nation's interest in being included in future economic opportunities related to hazard tree work within in our territories.

Yale First Nation holds all the required certifications to safely and effectively carry out this important work. We believe that this is a meaningful opportunity for us to strengthen our Nation's economic development while continuing to care for the lands that surround us.

With recent staffing changes at B.C. Parks, we are now in contact with Erin Kendall and have submitted a formal letter to open dialogue on developing a working relationship between Yale First Nation and B.C. Parks.

We look forward to building stronger partnerships that create more employment and training opportunities for our members.

CHIEF & COUNCIL UPDATE

Addressing Fishing Activities in Our Traditional Territory

Chief and Council wish to inform you of ongoing discussions concerning the operations of Great River Fishing Adventures within our traditional territory along the Fraser River.

Our community holds constitutionally protected rights to harvest fish and aquatic plants for food, social, and ceremonial purposes. These practices are integral to our cultural heritage and community well-being.

In a previous conversation with Mr. Dean Werk, operator of Great River Fishing Adventures, we emphasized the importance of respecting our traditional fishing eddies and ceremonial gathering sites. While Mr. Werk highlighted his longstanding presence in the area, we reiterated our deep-rooted connection to this land and river, which spans thousands of years.

Our goal is to foster a collaborative approach that ensures the preservation of our traditional practices alongside sustainable commercial activities. To this end, we have proposed a meeting with Mr. Werk and representatives from relevant organizations to discuss our concerns and explore potential avenues for cooperation.

We are committed to establishing a positive working relationship and hope to resolve this matter promptly. We will keep the community informed of any developments and outcomes from these discussions.
